Item 4 is hereby amended and restated in its entirety as follows:

(a) Amount Beneficially Owned: NAI Entertainment Holdings LLC ("NAI EH") beneficially owns 8,251,064 shares of Class A Common Stock; National Amusements, Inc. ("NAI") beneficially owns 30,110,899 shares of Class A Common Stock (including the shares owned by NAI EH); Sumner M. Redstone beneficially owns 30,110,939 shares of Class A Common Stock (including the shares owned by NAI and NAI EH).

(b) Percent of Class: 21.8% with respect to NAI EH; 79.6% with respect to NAI and Sumner M. Redstone.

(c) Number of shares as to which the person has:

(i) sole power to vote or to direct the vote: 8,251,064 shares of Class A Common Stock with respect to NAI EH; 30,110,899 shares of Class A Common Stock with respect to NAI (including the shares owned by NAI EH); 30,110,939 shares of Class A Common Stock with respect to Sumner M. Redstone (including the shares owned by NAI and NAI EH);

(ii) shared power to vote or to direct the vote: None;

(iii) sole power to dispose or to direct the disposition: 8,251,064 shares of Class A Common Stock with respect to NAI EH; 30,110,899 shares of Class A Common Stock with respect to NAI (including the shares owned by NAI EH); 30,110,939 shares of Class A Common Stock with respect to Sumner M. Redstone (including the shares owned by NAI and NAI EH);
