**TELECOM ITALIA SUCCESSFULLY CLOSSES 750 MILLION EURO  
2-YEAR BOND ISSUE**

**The operation contributes to the reduction of the average cost of Group debt**

**The issue was a private placement**

*Milan, 31 May 2006* - Telecom Italia today successfully closed a 750 million euro floating rate bond issue with maturity in June 2008.

With this new operation, Telecom Italia continues the process of refinancing maturing debt while reducing its average cost.
