CGII does not have investment power or voting power over any of the securities reported herein. However, by virtue of Rule 13d-3 under the Act, CGII may be deemed to "beneficially own" 2,127,870 shares or 5.9% of the 36,148,000 shares of Common Stock believed to be outstanding.

Capital Guardian Trust Company, a bank as defined in Section 3(a)(6) of the Act is deemed to be the beneficial owner of 2,127,870 shares or 5.9% of the 36,148,000 shares of Common Stock believed to be outstanding as a result of its serving as the investment manager of various institutional accounts.
