It was recently announced that CVS Health has agreed to acquire Aetna. Aetna's industry leading health care benefits and services combined with CVS Health's 9,700 retail locations, 1,100 clinics and integrated pharmacy capabilities will create a front door to health care. The two companies plan to build an entirely new health care concept that will deliver a better health care experience, reduce costs and improve access to trusted health care experts in communities across the country.

It is expected to close in the second half of 2018, subject to regulatory and shareholder approvals and other customary closing conditions and until then, CVS and Aetna will continue to operate in all respects as two independent companies.
