**Upside participation rate:** 375% to 425%\*

**Maximum return at maturity:** \$600 per security (60% of the stated principal amount)

**Barrier value:** For each underlying, 60% of its initial underlying value  
For each \$1,000 stated principal amount security you hold at maturity:

- If the final underlying value of the worst performing underlying is **greater than or equal to** its initial underlying value:  $\$1,000 + \text{the return amount}$ , subject to the maximum return at maturity
- If the final underlying value of the worst performing underlying is **less than** its initial underlying value but **greater than or equal to** its barrier value:  $\$1,000$

**Payment at Maturity:** · If the final underlying value of the worst performing underlying is **less than** its barrier value:  $\$1,000 + (\$1,000 \times \text{the underlying return of the worst performing underlying})$

### Selected Risk Considerations
