Prologis, a Maryland real estate investment trust (the Company), hereby amends this Registration Statement on Form S-8 for the purpose of removing from registration hereunder 4,291,562 of its common shares of beneficial interest, par value \$0.01 per share (the Shares). The Company has terminated its offering under the Prologis Employee Share Purchase Plan. In connection with the offering, the Company issued a total of 708,438 Shares.
