On September 21, 2011, the Compensation Committee of the Board of Directors of PowerSecure International, Inc., a Delaware corporation (the Company), adopted two new forms of Stock Option Agreements under the PowerSecure International, Inc. 2008 Stock Incentive Plan (the 2008 Plan), which provides for the grant of equity awards to the officers, directors, employees, advisors and consultants of the Company.
