(1) All of the 150,000 shares of common stock being sold are being sold pursuant to a Rule 10b5-1 Sales Plan, entered into and effective as of March 24, 2006 by and between CRT Capital Group, LLC, on the one hand, and each of Highland CDO Opportunity Fund, Ltd., Highland Equity Focus Fund, L.P., and Highland Legacy Limited, on the other hand. The representations of the reporting person regarding knowledge of material adverse information in regard to the current and prospective operations of the Issuer were made and were true and correct as of the date of adoption of the Rule 10b5-1 trading plan.

(2) On August 31, 2005, Highland CDO Opportunity Fund, Ltd. (CDO Fund) obtained 214,711 shares of common stock from ML CBO IV (Cayman), Ltd. (ML CBO) in connection with a distribution of 353,418 shares of common stock, in the aggregate, by ML CBO to certain noteholders of ML CBO, including CDO Fund.
