Levitt Corporation owns approximately 31% of the outstanding common stock of Bluegreen Corporation (Bluegreen), a publicly traded company, and accounts for its interest under the equity method of accounting. Bluegreen announced that it was restating its financial results for prior periods. Final results of that restatement were only recently made available to the Company. We were unable to complete the preparation of our Annual Report on Form 10-K for the year ended December 31, 2005 (the Form 10-K), within the required time period, without unreasonable effort or expense because we could not timely complete our analysis of the impact of Bluegreen s restatement on our financial statements after receipt of final information from Bluegreen.

In addition, the Company has not completed its review of the effectiveness of the Company s internal control over financial reporting as required by Section 404 of the Sarbanes-Oxley Act of 2002 for the year ended December 31, 2005. The Company has identified certain control deficiencies and is continuing its assessment as to whether any of such control deficiencies, either individually or in combination, constitutes a material weakness in the company s internal control over financial reporting as of year end. Completing this assessment has also required additional time and effort.
